This agreement is between Texas Image Volleyball ("TIV) and the above named player and player's parents or legal guardians. TIV would not allow player to participate in any activities without this agreement.

The Following team player rules must be followed at all times:

- 1. The player will follow and abide by all USAV rules for practice, tournaments sites or any other location of which player is representing or participating in TIV activities of any kind (player, parent and legal guardians acknowledge receipt of the applicable USAV rules).
- 2. The player will attend every scheduled practice unless:
  - a) Player is injured or sick to such a degree that player cannot, under the direction of a licensed physician, participate (player, parent, and/or legal guardian shall provide evidence of injury or sickness upon request of TIV).
  - b) Other conflicts or family emergencies, which must be approved by the player's coach in the coach's sole discretion.
- 3. The player, parents and legal guardians and all persons under their control, including but not limited to relatives, friends and persons associated with them will treat all teammates, coaches, referees and other officials, spectators and other persons in authority with courtesy and respect at all times.
- 4. The player will keep all uniforms and equipment available when needed, replace when lost (at the players expense), and return to TIV if requested.

  (player, parent and legal guardians acknowledge receipt of the applicable USAV rules).
- 5. The player will follow all curfew rules when attending an out of town tournament, and understand that a violation of these curfew rules will suspend the player from participation in that tournament. Also, the player must go before her coach and club director before the player is reinstated.
- 6. The player will not use alcohol, drugs or any other controlled substance.
- 7. The player will not smoke or use any form of tobacco products.

These rules may be adjusted from time to time in the sole discretion of TIV. Any violation of these rules will be subject to appropriate discipline of the player of other action of which the player, parents and legal guardians agree is in the sole discretion of TIV. ## TEXAS IMAGE VOLLEYBALL (Payment Agreement)

This is a contract between Texas Image Volleyball ("TIV") and the undersigned ("Obligor"), whether one or more. This payment agreement is referred to herein as Agreement.

#### Payments Schedule

The Obligor agrees to pay TIV, or TIV's successors or assigns, the total amount of \$\_1,315.00\_ according to the following schedule:

First installment of \$\_600.00\_ at the time of signing of this Agreement; Four (4) additional installments in the amount of \$\_178.75\_ due on:

(1) November 1, 2023, (2) December 1, 2023, (3) January 1, 2024, (4) February 1, 2024

Use PayPal Credit and have Interest Free 6 Payments of \$119.17.

Installments will become overdue on the fifth (5th) day after the installment due date set forth above. If a payment becomes overdue, the Player (as referenced below) will be suspended without notice from and may not participate in any and all club activities whatsoever until all overdue installment(s) plus a late charge of thirty dollars (\$30.00) is paid in full. An additional thirty dollar (\$30.00) late charge will be added every thirty (30) days on past due installments until all amounts under this Agreement are brought current.

It is anticipated that the team will be composed of approximately eleven (11) players. Each player will receive the following equipment:

1 Jersey, 1 Sweatshirt, 1 Pair of Spandex, 1 Practice Shirt, 1 Pair of Kneepads, 1 Window Decal

It is anticipated that the team will be registered for 8 tournament days.

#### **General Terms and Conditions**

If the team qualifies for USAV Nationals the players on the team are required to participate in Nationals.

If the Player is suspended, on probation, or otherwise disciplined for violation of any team, league or applicable governing body rule whatsoever or if the Player quits or is no longer participating in TIV activities for any reason, it is agreed and the Player and Obligor understand that the total amount, including all unpaid installments and late charges under this Agreement must still be paid and this Agreement is not affected. Upon the occurrence of any such event or the failure to pay amounts due hereunder, TIV may accelerate the total amount due under this Agreement as immediately due and payable. The total amount due and related installments may be adjusted upward at any time without notice if the number of members/players on the team decreases or other additional costs are incurred by TIV. Player and Obligor understand that the number of players and tournaments may be adjusted at any time without notice in the sole discretion of TIV. Obligor agrees to pay said amounts under a modified installment schedule determined in the sole discretion of TIV. In no event shall the total amount due be less than the amount set forth herein. Nothing in this Agreement is intended to exceed the amounts allowed or charge Obligor for amounts in excess of any applicable usury law. In the event that an amount charged under this Agreement exceeds an amount under applicable usury law, that amount is cancelled to the extent it exceeds said usury law and this Agreement shall be modified so that it is in compliance with any applicable usury law. TIV's performance under this Agreement may be excused or delayed due to any act or occurrence outside the reasonable control of TIV, which includes but is not limited to, acts of war, insurrection, riot, pandemics, inclement weather, or governmental moratoriums or restrictions ("Force Majeure"). No Force Majeure event shall entitle Obligor to any refund or reduction in the payments due under this Agreement. In the event this Agreement and the amounts due hereunder are turned over to a collection agency or attorney for collection and enforcement, Obligor shall be entitled to all fee and expenses associated herewith. This Agreement is the entire understanding between Player, Obligor and TIV and no oral promises or representations have been made by or relied upon by any of them. This Agreement cannot be modified except by a subsequent writing signed by the parties to this Agreement. Obligor may not assign this Agreement. If any term of this Agreement is invalid or unenforceable, that term shall be stricken and the remainder of this Agreement shall not be effected. This Agreement is performable in Tarrant County. Texas and venue shall, for all purposes be in Tarrant County. Texas.
